99 MMBTU/HR TRAILER-MOUNTED BOILERS ADDED TO NATIONWIDE BOILER'S FLEET

n keeping with the company's commitment to provide customers with the highest quality boiler equipment, Nationwide Boiler has added two new Nebraska 82.500 lb/ hr trailer-mounted boilers and one new Babcock & Wilcox 82,500 lb/hr skid-mounted boiler to the company's boiler fleet. These units are designed with low NOx burners and the latest equipment upgrades, including the option of an EconoStak economizer for added fuel efficiency and operational cost savings and a CataStak™ selective catalytic reduction system for NOx emissions as low as 5 ppm.

Additionally, these units are designed to provide the maximum steam output without triggering the federal governments' new source performance standard (NSPS) requirement for a continuous emission monitoring system (CEMS). NSPS regulations require that users operating a boiler with a maximum designed heat input rating of 100 mmbtu/hr or higher install costly CEMS equipment, along with submitting emissions compliance reports to the Environmental Protection Agency (EPA) on a regular basis.

All units are Boiler are capable of producing up to 82,500 lbs/hr of 350 or 500 psig saturated steam, avoiding the need to install, calibrate and maintain CEMS systems or prepare compliance reports. A well known engineer from General Electric Co., W.J. King, observed that the chief obstacles to success are likely to be of a personal and administrative nature, rather than technical. King's, *The Unwritten Laws of Engineering*, published in 1944, is a classic of engineering literature that describes his "unwritten" engineering laws into a guide for professional conduct for those new to the engineering field.

Some of these "laws" are so basic that they are being paraphrased below without explanation, but I recommend you take the time to read them, however obvious they appear. Engineers and business people alike will appreciate such a list and it can be applied to everyday work duties, in addition to prescribed work ethics.

- However menial and trivial your early assignments may appear, give them your best efforts.

- There is always a premium upon the ability to get things done, and this requires energy, resourcefulness, and persistence.

- Before asking for approval of any major action, have a definite plan and program worked out to support it.

- Strive for conciseness and clarity in oral or written reports; be extremely careful of the accuracy of your statements.

- One of the first things you owe your supervisor is to keep him informed of all significant developments.

INFORMATION LINE

- Whenever your work affects another department or another employee, make sure they know what you are doing, and why.

- Get the facts, make an analysis, apply judgment, and make a decision; do not hesitate or be indecisive.

- Be interested in the people who work with you or for you, and treat them as you would want to be treated.

- Regard your personal integrity as one of your most important assets.

- Be careful of your personal appearance; if you are an executive, look the part.

Many additional "laws" could be added to the list however, the following summarizes the above information best:

"You should make an effort to learn what is expected of you in your job. Realize that people do form first impressions of you, people do appraise your appearance, the way you conduct yourself, and your ability to accomplish assigned tasks. These evaluations are being made all the time."
