## "WORLD TRAVELER" BOILERS TAKE FLIGHT

Canada, Wales, China, Malaysia, Israel, Venezuela, Scotland, the Philippines, and now Australia can be added to the list of countries where many of Nationwide's boilers have traveled. Whether a boiler is needed domestically or abroad, Nationwide Boiler has been delivering quality boilers across the world by air, sea and land for over 40 years.

Most recently, we supplied a late model 70,000 pph trailer-mounted watertube boiler to our East Coast Partner, Powerhouse Equipment & Engineering Company, for a sale to a ConocoPhillips LNG plant in Australia. Powerhouse

received an emergency order from the customer to supply two boilers for quick delivery to Darwin, Australia.

The total weight of Powerhouse's 75,000 pph skid-mounted boiler and the Nationwide 70,000 pph boiler was almost 200,000 lbs.

The boilers were loaded into the Antonov AN124-100, an aircraft originally designed for the Russian Air Force that boasts a load capacity of 330,000 lbs.

Delivery of the boilers took a total of three days, having to stop to refuel in Alaska, Russia and the Philippines. The boilers are planned to be in operation this month.

During a recent business trip, I stopped in at a local book store and picked up a copy of the #1 Wall Street Journal and #1 Business Week best seller, StrengthsFinder 2.0, by Tom Rath. I found this book to be a useful assessment tool used for defining and developing your strengths and talents, often overshadowed by our shortcomings which we are always willing to change.

The book includes an access code which is to be used in conjunction with the StrengthsFinder 2.0 web site. From there you complete a twenty minute assessment which guides you through a series of questions aimed to pinpoint who you are based on your attitude towards various situations. Once completed, you will be introduced to your top five strengths or themes, along with a detailed report of each theme. It includes a description of each theme, a discussion on what makes you stand out from others, ways to use your strengths to your advantage and a list of "ideas for actions".

I found the ideas for actions most useful. They incorporate your talents into real world situations to help you problem solve and continually improve your relationships, both personally and professionally. For example, one idea of action it suggested for me was to volunteer my analytical talents to others by helping those who have a difficult time bringing structure to their ideas. ## SCR TEST RESULTS BEYOND DETECTION

hen it comes to product performance and emissions testing, Nationwide Boiler's CataStak™ SCR System continues to achieve results that not only meet ultra low NOx guarantees, but exceed them.

Another success story to add to the list of "overachievers" takes place in California's Central Valley and involves a major food manufacturer. The company contacted Nationwide Boiler to help meet future air quality emission limits of 5 ppm NOx for a firetube boiler.

The original equipment consisted of a 700 hp (29.3 MMBtu/hr) natural gas fired Cleaver-Brooks boiler, equipped with a low NOx burner utilizing flue gas recirculation (FGR). Nationwide Boiler's CataStak SCR System was guaranteed to operate at less than 5 ppm.

When testing was complete the unit was certified by a third party testing company to operate with less than 0.5 ppm NOx, CO emissions of 13.3 ppm and average ammonia slip of only 0.3 ppm. The low to high fire stack temperature operated between 330 F and 366 F.

Overall, reported NOx emission results were so low (zero), that they surpassed the minimum reportable detection limit of the emissions testing device used. The testing apparatus did not have the capabilities to report results that were at one time unable to be achieved, but are now becoming more common.

Today, the unit continues to meet its emission requirements with ease due to the reliability of the CataStak SCR System.

Obtaining near zero NOx is no longer a fairy tale with Nationwide Boiler.

## SAFETY MILESTONE ACHIEVED: 1,500 DAYS WITHOUT A LOSS TIME ACCIDENT

Nationwide Boiler's commitment to safety became a reality on March 17<sup>th</sup> when the milestone of 1,500 days without a loss time accident was achieved. That equals to more than four years, or 36,000 hours of safe practices, processes and operations.

Safety is an integral part of Nationwide's quality program and it is overseen by a six member team of employees who perform facility inspections and review employee suggestions. More importantly is the entire Nationwide Boiler team of employees (in the shop, in the field and in the office), who have accomplished this milestone by applying safe work processes and procedures during their day-to-day work activities.

For those in the shop who are consistently servicing and maintaining Nationwide's large boiler fleet, this means being proactive and not being afraid to ask questions when things are unclear or when one is unsure of how to do a particular task. Trying to figure out something along the way without the complete knowledge of all the details can lead to an unsafe work environment.

It also means maintaining a positive attitude attitude on to other team members. Positive actions and positive thinking spreads quickly that has also helped contribute to this important milestone.

Nationwide's approach to safety involves proactive programs and ongoing procedures and developmental training. These actions include the following:

- Safety orientations for new employees
- Ongoing training and safety certifications for shop employees
- Employee substance abuse testing
- Incentive programs for safety suggestions
- Implementation of safe work procedures in order to prevent accidents
- Emergency preparedness drills

In the past four years Nationwide has developed thirty-seven shop safety modules and six office safety modules. There are also fortyone internal and external inspection/permit programs. In addition, the shop incentive program has a 100% participation rate, while the office's rate is 99%.

Knowing, understanding and performing safely while working has been a top priority at about safety while on the job and passing that Nationwide Boiler. Through the ongoing efforts of each employee, including their positive attitude and participation, all employees have and is quite effortless.
